

## Northrop Grumman Federal Credit Union Gift Card Sweepstakes Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

- 1. Eligibility:** The Northrop Grumman Federal Credit Union Gift Card Sweepstakes ("Sweepstakes") is open to all legal residents of United States who are at least eighteen (18) years old at the time of Sweepstakes entry. Employees, officials and volunteers of the Credit Union, their family members and members of the same household, are not eligible.
- 2. Sponsor:** Northrop Grumman Federal Credit Union ("Credit Union"), 879 W. 190th Street, Suite 800, Gardena, CA 90248 (Headquarters)
- 3. Timing:** The Sweepstakes begins on December 11, 2017 at 8:00 a.m. Pacific Standard Time ("PST") and ends on January 31, 2018 at 11:59 p.m. PST (the "Promotion Period").
- 4. How to Enter:** There is one (1) way to enter the Sweepstakes.

**Entry Form:** Eligible participants may complete an entry form available at the Credit Union's Melbourne Gateway branch during normal hours of operations at 1421 Gateway Drive, Melbourne, FL 32901.

One (1) entry per entrant. Entry form must be submitted at the Melbourne Gateway branch. Mechanically reproduced or hand-stamped entries or entries generated by any automated means will not be accepted. Incorrect, illegible and incomplete entries are void.

Any attempt by any participant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations, or any other methods will void that participant's entries and that participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification.

- 5. Entry Verification:** Entries must be received before the close of the Promotion Period in order to be counted. Proof of mailing does not constitute proof of delivery. Sponsor is not responsible for lost, late, stolen, incomplete, illegible, inaccurate, undelivered, delayed, or misdirected entries. Entries become the property of the Sponsor and will not be acknowledged or returned. Incomplete entries or entries not complying with these Official Rules are subject to disqualification at the Sponsor's sole discretion.
- 6. Description of Prize:** There will be two (2) prizes awarded. The two prizes will consist of \$75 Gift Cards. One gift card will be awarded to each winner. The Credit Union has purchased the Gift Cards.
- 7. Selection, Notification and Winner:** Two (2) names will be selected by the Sponsor in a random drawing conducted at 11 am (Pacific Time), February 1, 2018 in the Credit Union's Headquarters in Gardena, CA. Winner does not need to be present to win the prize. Sponsor will contact the winner using the information provided on the entry form. The winner has seven (7) business days to respond. If winning entry and cannot be contacted or declines the prize, an alternate winner will be drawn. The winner is responsible for all applicable taxes and fees. The winner will be required to present valid proof of identification when picking up their prize. Also, at that time, winners will be required to sign a release to receive the prize and grant the Credit Union the authority to use his or her name, and likeness in public advertising. Sponsor has permission to use and publish photos in any and all media for any purpose whatsoever; and include the winner's full names to identify the photos.
- 8. Odds of Winning:** Odds of winning will be determined by the number of valid entries.
- 9. Applicable Law:** The Sweepstakes is open to individuals as described in Eligibility section (item #1) of this document. This Sweepstakes is subject to applicable federal, state and local laws. Void where prohibited.
- 10. Agreement:** Participation in the Sweepstakes constitutes entrant's full name and unconditional agreement to these Official Rules, which are final and binding in all matters related to the Sweepstakes.
- 11. Reservation of Rights:** Sponsor reserves the right, in its sole discretion, to modify or terminate the Sweepstakes in the event of any act, occurrence, or reason that it believes would corrupt the integrity, administration, or fairness of Sweepstakes.
- 12. Release of Liability:** By participating in the Sweepstakes, participants agree to release, discharge, and hold harmless Sponsor, its respective affiliates, subsidiaries, officers, employees, and any other individuals engaged in the development or execution of the Sweepstakes, from any liability, claims, losses, and damages arising out of or relating to their participation in the Sweepstakes or the acceptance, use, misuse or possession of any prize received.
